As at the date of the AGM, the total number of shares of the Company in issue was 904,189,000 shares, which was the total number of shares entitling the shareholders to attend and vote on the resolutions proposed at the AGM. There were no restrictions on any shareholder casting votes on any of the proposed resolutions at the AGM. None of the shareholders have stated their intention in the circular of the Company dated 11 May 2022 that they would vote against any resolution or abstain from voting at the AGM.

The Company's share registrar, Computershare Hong Kong Investor Services Limited, acted as the scrutineer for the vote-taking at the AGM.
